WHAT IS CARANUA?

Caranua is an independent State Body set up to help people who, as children, experienced abuse in Institutions in Ireland and have received settlements, Redress Board or court awards.

WHAT DO WE DO?

We can help to get people the services they are entitled to as citizens. We can pay for services so that people have the supports they need and can give grants to individuals to source services themselves.

HOW CAN WE HELP?

What we provide will depend on the needs and circumstances of the individual who applies, but the areas we can help with are:

• Health and medical services

GP, dental treatment, chiropody, physiotherapy, occupational therapy, hearing aids, glasses, walking aids, wheelchairs, nursing care, home care

• Mental wellbeing

Counselling, psychological and psychiatric services, complementary therapies, help with addiction

• Housing

Insulation, extensions, adaptations, aids (ramps, rails) tenancy support, home help

• Education

Formal education courses leading to qualifications, lifeskills, other short courses

WHO IS ELIGIBLE?

People who received awards through settlements, courts or the Redress Board. We are unable to help family members or people who did not receive awards.

We cannot consider applications from people who are not eligible. We advise individuals as a first step to make sure they are eligible by filling and returning the form (right). We will then be able to advise on the next steps.

HOW TO APPLY FOR OUR HELP

- You can apply on our website or by post using our application form
- You can nominate someone to apply on your behalf
- You can get help making an application from someone of your choice or someone nominated by Caranua

We will be inviting applications from January 2014. Information and forms are on our website, and at Irish Embassies, Irish Welfare services, survivor support groups, community based and health services and citizen information services.
